(Applicant has already graduated from high school and is currently attending college.)

The Carolinas Food Industry Council (CFIC) is the premier organization representing all aspects of food distribution in both North and South Carolina. In an effort to contribute to the communities that have made the industry what it is, CFIC has established a scholarship program awarding **30 scholarships** each year!

Who Is Eligible

- A **student** whose **parent** is a permanent, **full-time employee** of a CFIC Retail, Wholesale or Supplier Member Firm. (*Parent must be employed for at least **one-year** as of 1/1/12.*)

OR

- A **student** who is a **part-time employee** of a CFIC Retail, Wholesale or Supplier Member Firm. (*Student must be employed for at least **six-months** as of 1/1/12.*)

NOTE: *The food industry employee (whether a parent or student) must work at a Retail, Wholesale or Supplier Member location in **North or South Carolina**, and must be employed at the time the winners are selected in June.
Qualified scholarship recipients may attend a college located in any state.*

Scholarship applications and official transcripts must be post-marked by: **April 2, 2012**.

(Winner is responsible for delivering the check to the appropriate office within the college.)
